TERMS OF SERVICE

These terms were last updated on December 17, 2016.

General Provisions

Welcome to the website of Dreamware, Inc. d/b/a Auto.Live ("Auto.Live," "we," "us," "our"). The following Terms of Service apply when you visit our website (<https://nickmp.local>) ("the Site") or use Auto.Live's mobile or other online services (collectively, the "Service"). By using our Service, you agree to be bound by, and use our Service in compliance with these Terms of Service. **IF YOU DO NOT AGREE TO THESE TERMS OF SERVICE, DO NOT USE OUR SERVICE.**

Auto.Live is a vehicle listing and information service that brings together buyers and sellers. Auto.Live is not an automobile broker or dealer and does not sell, exchange, buy, or offer for sale, negotiate or attempt to negotiate, a sale or exchange of an interest in any vehicle. Auto.Live is not a party to any transactions or agreements entered into between users. If you purchase or sell a car using the Service, you are contracting directly with the car seller or buyer. Auto.Live has no control over the conduct of, or any pricing or other information provided by car buyers or car sellers, and Auto.Live disclaims all liability in this regard. Auto.Live does not (a) guarantee or ensure any car, price, offer or transaction between a buyer and seller, (b) transfer vehicle titles on behalf of buyers or sellers, or (c) warehouse, ship or store any cars.

Although Auto.Live is not a party to any vehicle sale contract between vehicle buyers and sellers that originates on or through the Service, Auto.Live offers other ancillary products and services provided by third parties including, but not limited to, vehicle financing, vehicle inspections, vehicle shipping and secure payments.

We reserve the right, at our sole discretion, to change or modify portions of these Terms of Service at any time. If we do this, we will post the changes on this page and will indicate at the top of this page the date these Terms of Service were last revised. We will also notify you, either through the Services user interface, in an email notification or through other reasonable means. Any such changes will become effective no earlier than fourteen (14) days after they are posted, except that changes addressing new functions of the Services or changes made for legal reasons will be effective immediately. Your continued use of the Service after the date any such changes become effective constitutes your acceptance of the new Terms of Service.

You agree that these Terms of Service are supported by reasonable and valuable consideration, the

without limitation, your access to and use of the Service and data, materials and information available at or through the Service.

Buyers and Sellers

All buyers and sellers must be at least 18 years old to use the Auto.Live Service and by using the Service, you represent that you are at least 18 years old.

Information about a particular vehicle is supplied by the seller, not by Auto.Live. Although Auto.Live may provide a list of standard vehicle features and equipment based on the Vehicle Identification Number of a vehicle, the Seller is responsible for verifying the listed information. The price and other terms of any sale are arranged by negotiation between the buyer and the seller. Any savings or discount information that you may receive from a user is offered and provided directly to you by the user, and is not provided or guaranteed by Auto.Live. Auto.Live is not responsible for incorrect information given by buyers or sellers, including information regarding vehicles or photos of vehicles. Auto.Live cannot verify the information or photos that sellers post. In order to transfer a vehicle, the Service requires the seller to provide the buyer with a title to the vehicle. The buyer may request that the seller provide additional documents. Any such requests are between the buyer and seller and Auto.Live is not responsible for communications or documents exchanged by buyers and sellers.

When using this Service to buy or sell a vehicle, please use common sense and good judgment. Any reliance on the information on the Site or provided through the Service is at your own risk.

Vehicle Pricing

The prices listed by sellers on Auto.Live exclude government fees and taxes, finance charges, registration, license and titling fees, regulatory and electronic processing charges, and/or emission testing charges.

Listing Your Vehicle

To list a vehicle for sale on Auto.Live, sellers are required to provide certain identifying and contact information. The information must accurately identify the seller and the method of contact must permit buyers to communicate directly with the seller. You may not charge any potential buyer for information about any vehicle listed for sale on Auto.Live's Service, nor may you use our Service to promote, without our prior written permission, any other website, product, or service. Sellers must be prepared to sell their

vehicles at the price at which, and on the terms on which, they are listed. You must have possession of the actual vehicle listed and the proper authority to transfer title. Auto.Live reserves the right (but assumes no obligation) to delete, move, or edit any listings that we consider unacceptable or inappropriate, whether for legal or other reasons.

Dealer-Specific Rules and Regulations

Any vehicle dealer ("Dealer") using the Service must be currently licensed as a dealer in the state(s) in which Dealer operates.

In order to use the Service, Dealer must open an account with Auto.Live and agree to payment of a Monthly Service Fee. Each month, Auto.Live will charge Dealer's account for the Monthly Service Fee. Dealer's use of the Service shall continue on a month-to-month basis. Dealer may terminate its use of Auto.Live's Service, effective as of the first day of the following month, by providing 30 days notice to Auto.Live.

Because we stand behind our service, Auto.Live provides dealers with a 90-day money back guarantee. If, prior to the end of your first 90 days of service, you provide written notification to us of your decision to terminate our services, you will receive a full refund for all of your Monthly Service Fees. The term "full refund," however, does not include fees paid that are not connected with the Monthly Service Fee, such as fees for buying vehicles, vehicle inspections, shipping fees etc.

Dealer must abide by all local and state regulations pertaining to offering/advertising vehicles for sale and buying and selling vehicles. After a dealership purchases a vehicle, the dealership's purchase funds will be released to the seller 48 hours after delivery of the vehicle, or sooner if instructed by the buying dealership. If a dealership is not satisfied with a vehicle it has purchased, the dealership may return the vehicle to the seller by arranging to ship the vehicle and delivering the vehicle to a vehicle shipper within 48 hours after delivery of the vehicle to the dealership. The purchasing dealership will be responsible for the expense of shipping the vehicle back to the seller.

Financing, Vehicle Inspection and Shipping Services

If you obtain financing, vehicle inspection services or shipping services with third parties available through our Service, additional terms and conditions apply.

License to Use our Services

Subject to these Terms of Service, we grant to you a limited, personal, non-exclusive, non-transferable license to use our Service for your personal use and not for resale or further distribution. We (and where applicable, parties from whom we have obtained licenses) retain all right, title and interest in and to our Service, including all related intellectual property rights.

Access to our Services
